

## Special Event Permits

Two additional Special Event Permits may be provided in any given year. Special event permits will only be available during the months of March, April, June, September, and October. These special permit dates cannot conflict with any permitted date, Memorial Day or Labor Day holiday weekends, or National Hunting and Fishing Event Days Celebration.

Determination to offer a Special Event Permit will be solely a WVDNR decision and will be based only on the following criteria:

- The event must be of regional or national significance;
- The event must be sanctioned by a regionally or nationally affiliated angling or conservation organization;
- This organization must have a proven record of hosting competitive angling events;
- The event must include both education and conservation related components, as well as a competitive angling component; and
- A minimum of 25 boats must be registered for the event.

### Special Event Permit Selection Procedure

- Applications for a Special Event Permit must be submitted to the WVDNR-Wildlife Resources Section in writing by **December 1, 2014**.
- The application (enclosed) must include a clear and detailed description of the proposed event and an explanation of how the event will meet the described criteria.
- The WVDNR-Wildlife Resources Section will notify the organization of the decision by December 31, 2014.
- Special events are not allowed during any previously selected competitive fishing event dates. These dates will be available on the WVDNR web site.
- Any organization selected for a Special Event Permit cannot sell or trade the permit for a value.
- Organizers must follow all guidelines and regulations concerned with angling, facility use, proper handling and disposal of fish, and reporting procedures.
