#### **APPLICATION INFORMATION**

1. Residents and nonresidents are eligible for a permit to participate in the 2010 controlled bear hunt with dogs either on the Nathaniel Mountain or Short Mountain WMAs, Hampshire County, WV. **Follow the instructions on the accompanying application exactly.**
2. Hunting parties will be limited to the four individuals (including underage hunters) listed on the permit application. No applicants name will be allowed on any other application or any other party. Hunting parties will be limited to eight dogs. These rules shall apply during all phases of the hunt and at all times during the course of the day.
3. Hunts will be limited to two consecutive days of hunting and one additional consecutive day to find dogs that may be left in the woods. This will limit hunts to two parties per week, with no hunting allowed on Sundays. Hunters not listed on the permit may not participate in any way during the allowed days.
4. Seven hunts will be available to apply for during the four week bear season which runs from December 6-31, 2010. Parties will be drawn randomly to fill all hunts by order of date: Dec. 6-8, Dec. 9-11, Dec. 13-15, Dec. 16-18, Dec. 20-22, Dec. 23-25, and Dec. 27-29.
5. There is to be absolutely no killing of bears on private property while hunting with a party covered by this permit.
6. Trespassing on private property will not be tolerated.
7. Applications must be signed, legible, complete, and received by the WV Division of Natural Resources, Elkins Office, postmarked no later than October 31, 2010. Violation of any conditions will disqualify all party applicants on an individual application.
8. Hunt dates are nonnegotiable.
9. All hunting regulations of the West Virginia Division of Natural Resources will apply to this hunt. The bag limit is one bear per party for the duration of the hunt and will apply to the licensed hunter's season bag limit as established for the state.
10. Applicants should be sure to include the verifiable county dog tax license numbers for at least four of the dogs they plan to use on a hunt they may be drawn for. All dogs listed must be owned by at least one of the applicants.
11. Applicants should mark which Wildlife Management Area for which they are making application.
12. First applicant listed will serve as permit holder for the party and will be the only applicant notified if drawn. This applicant will be notified no later than November 19, 2010.
