Application Instructions

1. West Virginia Residents and holders of West Virginia Lifetime Licenses may apply for a permit to participate in the Stonewall Resort State Park Controlled Deer Hunt on **November 18-20, 2013**. Hunters may apply individually or as part of a two person party and may use any weapon legal for deer hunting in West Virginia. One (1) deer may be taken by each hunter. Only antlerless deer may be taken during this hunt, except that each day of the hunt an on-site lottery will be held which will allow up to four (4) hunters to hunt an either sex deer. Follow instructions on the accompanying license application exactly.
2. All applicants must designate the hunting method they wish to hunt. All persons applying as a party must hunt the same method of hunting. The hunt area is divided into two zones; a Fixed Stand Zone and a Free Roaming Zone. In the Fixed Stand Zone there are 2 hunting methods. Hunters selected for fixed tree stand sites must hunt from elevated tree stands (ladder or self climbing), which they must provide, placed in designated trees. Hunters selected for ground blind stands must hunt from within a ground blind located and provided by the agency. In the Free Roaming Zone hunters may hunt from the ground or from portable tree stands with firearm or bow. They are not limited to a stationary location. The hunter(s) must choose only 1 of the 5 hunting methods which are: 1)Free Roaming Archery or Firearm, 2)Fixed Stand Archery, 3)Fixed Stand Firearm, 4)Fixed Ground Blind Stand Firearm, or 5)Class Q Fixed Stand. A Class Q hunter is a physically challenged hunter permanently disabled in both lower extremities. Party hunters which include a Class Q hunter must hunt from the same Class Q stand.
3. Applications must be signed, legible, complete, and postmarked by August 19, 2013. An individual's name may only appear on one application. Violation of any of these conditions will disqualify the applicant. Permits will be selected at random for each hunt day. The applicant may request to be placed on the lottery for no more than one (1) hunt day.
4. Each hunter must possess a valid West Virginia Hunting License (or be legally exempt from purchasing a license) on the day of the hunt. A safety belt is required to be worn while hunting from an elevated stand. Scopes are allowed on all legal firearms.
5. Hunters who apply and are not selected for the hunt are eligible to be entered into a lottery on the morning of the hunt for any "no show" sites. Hunters who check this box will be mailed an eligibility card which they will present on the morning they wish to be considered for any unfilled sites. Choosing this does not affect your eligibility for the selection of permits.
6. West Virginia Division of Natural Resources hunting regulations will apply to this hunt. However, deer taken during this hunt will NOT count against the hunter's annual deer season bag limit.
7. These rules and regulations, along with all applicable deer hunting regulation will be strictly enforced. Any violation may result in prosecution, expulsion from the state park and elimination from the remainder of the hunt.
