## 2013 ANTLERLESS DEER SEASON

### SELECTED WILDLIFE MANAGEMENT AREAS, STATE FORESTS AND COUNTIES OR PORTIONS THEREOF ONLY



1. Bona fide resident landowners, their resident children, or bona fide resident tenants who live on the land are not required to purchase a Class N antlerless deer hunting stamp for antlerless deer hunting on their own land.
2. Hunting will be limited on seven (7) WMAs, three (3) State Forests and in ten (10) counties, or portions thereof, to residents, non-residents and lifetime license holders who apply for and receive a permit for the specific area. These WMAs, SFs and counties are listed in green on the front of this card. Deer regulations for WMAs and SFs other than those listed can be found in the 2013-2014 Hunting and Trapping Regulations Summary.
3. Application must be signed, dated, legible and complete, and received by the DNR Application Section by August 19, 2013. An individual's name may appear on only one application. Violation of these conditions will disqualify the applicant.
4. A separate random selection will be made by computer for each area. Each applicant will be included in the drawing for the area selected. Successful applicants will be sent an "Eligibility Card" (permit) in October 2013. This permit will indicate the WMA, SF or county which the applicant may hunt and provide instructions for obtaining a Class N/NN stamp. Neither the permit nor the Class N/NN stamp may be transferred to another person, nor may the area of hunt be changed.
5. Any hunter under 15 years of age must be accompanied by a licensed adult. To participate in the antlerless hunt, the adult and youth must hold a valid permit for that same area. Successful applicants hunting on one of the (7) WMAs, (3) State Forests and in ten (10) counties or portions thereof, which require a permit, must have a Class N/NN stamp.
6. Forty three (43) counties, or portions thereof, will have an unlimited number of Class N/NN stamps for resident and nonresident hunters. (See the 2013-2014 Hunting and Trapping Regulations Summary for the list of counties.)
7. See the 2013-2014 West Virginia Hunting and Trapping Regulations Summary (available from any West Virginia hunting and fishing license agent) or visit the West Virginia Division of Natural Resources Web site, [www.wvdnr.gov](http://www.wvdnr.gov), for further information.
8. Any person born on or after January 1, 1975, must complete an approved Hunter Education course prior to purchasing any base hunting license with the exception of the Apprentice Hunting and Fishing Licenses.

- Enter the WMA, SF or county codes for your first and second choices in the boxes in Item **B** above. A second choice is optional.

- Each applicant must fill out his/her section of Item **A**.
